Chapter 1: General rules

Article 1: (name)

This organization is displayed as On the Wings of Osaka (abbreviated as "OWO").

Article 2: (Purpose)

Conduct the following businesses to achieve the vision of the incorporation prospectus.

- 1. Business activities for achieving supply of parts such as investigation, research, development, launching products, etc. related to next-generation aircraft.
- 2. Businesses for providing information on next-generation aircraft.
- 3. Business to establish a mechanism to maintain confidentiality of development data and transaction relationship data, especially a mechanism to maintain confidentiality regarding the handling of electronic data
- 4. Business to promote interaction between members
- 5. Business to promote interaction with organizations, companies, institutions, etc. that meet the purpose of the corporation, including aircraft-related companies
- 6. Joint ventures related to testing of aircraft related parts, trial manufacture, order acceptance, sales channel development, etc.
- 7. Providing necessary information to solve technical issues and management issues faced by the members, and business related to consulting.
- 8. Business for education and training of personnel related to aviation such as aviation maintenance, aviation system, private aircraft pilot etc.
- 9. Other businesses required to achieve the purpose of the corporation

Article 3: (location of main offices)

The corporation has its main office in Osaka City, Osaka Prefecture.

Article 5: (Institutions)

This organization, in addition to the general body of employees and directors considers the board of directors and auditors also as an organizational body.

Chapter 2: Members

Article 6: (Categories)

The members of this corporation shall be the following four types, and full members shall be employees under the Act on the General Incorporated Association and General Foundation (hereinafter referred to as the "General Corporation Act").

- (1) Regular members: individuals or groups who joined in favor of the purpose of the organization.
- (2) Semi-regular members: an individual or group who approves the activities of the organization and has joined for the purpose of supporting the activities of the corporation.
- (3) Supporting members: Individuals or groups who receive various information sent by this corporation
- (4) Special members: persons recognized as necessary for achieving the purpose of article 2 above and have obtained approval of the board of directors.

Article 8: (Admission fee and membership fee)

- 1. Regular members must pay the admission fee and membership fee separately defined at the general meeting of employees.
- 2. Semi-regular members and supporting members must pay the dues separately specified at the General Assembly of Employees.
- 3. Even if the members lose their qualifications, the corporation shall pay for the existing admission fee, dues and other contributions.

Chapter 3: Employee General Meeting

Article 11: (type)

There are two types of employee general meeting of the corporation: regular general meeting of members and temporary general meeting of members.

- 2. The number of votes permitted at the general meeting of employees shall be one for each regular member.
- 3. At the general meeting of employees, the opinions of advisors, associate members, and advisors shall be heard.

- 4. This corporation may have consultants and advisors.
